**Employees assigned to P1, P2, and P7, will receive the Referendum Retirement Accruing Supplement (RRAS) of 20% of Base Salary.*

The Daily Rate shall be calculated by dividing the Annual Salary by the non-lapsed time/actual workdays (196 days) exclusive of recess days. The Hourly Rate shall be calculated by dividing the Daily Rate by the non-lapsed hourly rate/actual work hours (6.84 hours or 7.5 hours for Security Monitors) exclusive of lunch. However, rates in the Portal and on the pay statement reflect the lapsed time (215 days) for 10-day pay checks for recess days.
