The Hourly Rate shall be calculated by dividing the Daily Rate by the non-lapsed hourly rate/actual work hours (6.84 hours or 7.5 hours for Security Monitors) exclusive of lunch. However, rates in the Portal and on the pay statement reflect the lapsed time (260 days) for 10-day pay checks for recess days.
